## Nazi Attacks on Americans

## By The Associated Press.

BERLIN, Oct. 12. — United States Consul General George S. Messersmith said tonight that nearly three-fourths of the cases in which Americans had been attacked by Nazi representatives were on file with the Consul General in Berlin in the form of sworn affidavits. The rest, he said, were in different consular offices in Germany. A list of the cases follows:

March 3-Leon Jaffe, attacked by brown-shirted troopers in Berlin.

- March 3—Henry H. Sattler, attacked by fifteen storm troopers in Berlin.
- March 4-Nathaniel S. Woolf, approached by six brown shirts who entered his Berlin apartment, drew revolvers and struck him in the face, later conducting him to a Nazi hang-out and thence to Gruenwald Woods and ordering him to leave Germany immediately.
- March 4-Edwin F. Dakin, threatened in his Berlin' quarters by storm troopers with pistols.
- March 7-Solomon Friedman, attacked by three storm troopers.
- March 7—Mrs. Max Schussler, molested in her Berlin home by storm troopers, who, showing revolvers, compelled her husband to sign documents while she stood nude before them.
- March 8—Louis Berman, attacked on a Berlin street by four brown shirts who threatened him with pistols and stole \$285 and some personal papers.
- March 10-Herman I. Roseman, attacked in front of a department store, struck in the face.
- March 11—Mrs. Klauber, assaulted in her home at Munich by storm troopers.
- troopers. March 11-Julian Fuhs, attacked in his wife's restaurant in Berlin by a civilian and several storm troopers, who knocked him down.
- March 11—Edward Dahlberg, attacked and struck in the face in Berlin by storm troopers.
- March 13—Max Mayer Hausman, attacked by storm troopers at Mannheim.
- March 29-Julian Fuhs again attacked by same civilian and storm troopers in a restaurant; knocked down, kicked, threatened with revolvers. The consulate was informed a storm trooper had been discharged from the organization while Mr. Fuhs's assailant, Oskar Joost, was fined 50 marks.
- April 1—Bernard S. Lustig taken to a storm troopers' hang-out in Berlin, detained and subjected to indignities.
- April 1-Louis S. Chase molested and struck by storm troopers in

Berlin while in company of his sister; later taken to a Nazi hangout.

- April 3—Hirsch Roth taken by storm troopers from his apartment, threatened, detained and subjected to indignities.
- April 3—Mrs. Lilly Steinlauf Blutinger molested in her residence, threatened.

April 19—Herbert Baer arrested without cause at Karlsruhe, detained in custody without being informed as to the reason or permitted to communicate with the consulate; finally released May 10 on representations of the Stuttgart Consulate.

- June 21—Dr. Joseph Schachno severely beaten and maltreated at Koepenick.
- July 1—Walter Orloff arrested at the University of Greifswald for alleged Communist activities on mere denunciation and confession extorted through maltreatment.
- July 11—Samuel Danzig, university student at Halle, attacked by a storm trooper while leaving a restaurant.
- July 11—Thorsten Johnson, arrested at Stettin in a seaman's drinking place for an alleged derogatory remark concerning the Chancellor. Although the prosecuting attorney assured the consulate the case was not serious Johnson was sentenced to jail and finally released Sept. 8 on representations by the Berlin Consulate.
- Aug. 15—Harold B. Dahlquist, attacked in Berlin; struck in the face by a storm trooper.
- Aug. 15—Dr. Daniel Mulvihill, struck on the head by a storm trooper in Berlin.
- Aug. 16—Samuel G. Bossard, assaulted by five Hitler youths: knocked down.
- Aug. 16—Philip Zuckerman, attacked at Leipzig by a group of storm trooper, knocked down, stamped upon and removed to a hospital in Berlin, where he has been under constant medical treatment ever since.
- Sept. 1—Rolf Kaltenborn, hit in the face in Berlin while accompanied by his father, mother and sister.
- Oct. 10-Roland Velz, struck in the face twice by storm troopers at Duesseldorf.
