To the Honorable the U.S. District Court of Southern District of New York, N.Y.
The petition of JOSEPH GARBUS, hereby filed, respectfully shows:

(1) My place of residence is 895 Beck Street, Bronx, NY (2) My occupation is Hebrew Teacher
 (3) I was born in Minsk, Poland on November 1870 My race is Hebrew
 (4) I declared my intention to become a citizen of the United States on May 21st, 1936 in the U.S. DISTRICT
 Court of SOUTHERN DISTRICT at NEW YORK, NY
 (5) I am married. The name of my wife SARAH is Sarah
 we were married on September 1896 at Minsk, Poland he was
 born at Minks, Poland on December 1875; entered the United States
 at New York, NY on June 1901 for permanent residence therein, and now
 resides at 895 Beck Street, Bronx, NY I have 6 children, and the name, date,
 and place of birth, and place of residence of each of said children are as follows: Kitty December 1897, Morton December 1899,
both born in Poland Sam July 5, 1903, Anna March 21, 1905, Rose November 21,
1908, Charles February 28, 1912 all born in New Jersey, all reside in
Bronx, NY except Morton who resides in California and Rose who resides in
Brooklyn, NY

(6) My last foreign residence was Minks, Poland I emigrated to the United States of
 America from Glasgow, Scotland My lawful entry for permanent residence in the United States
 was at New York, NY under the name of Joseph Garbus
 on June 1900 on the vessel Yeronese

(7) I am not a disbeliever in or opposed to organized government or a member of or affiliated with any organization or body of persons teaching disbelief in or opposed
 to organized government. I am not a polygamist nor a believer in the practice of polygamy. I am attached to the principles of the Constitution of the United States
 and well disposed to the good order and happiness of the United States. It is my intention to become a citizen of the United States and to renounce absolutely and
 forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to The Republic of Poland and
(or) The Union of Soviet Socialist Republics
 of whom (which) at this time I am a subject (or citizen), and it is my intention to reside permanently in the United States. (8) I am able to speak the English language.
 (9) I have resided continuously in the United States of America for the term of 6 years at least immediately preceding the date of this petition, to wit, since
June 1900 and in the County of Bronx
 this State, continuously next preceding the date of this petition, since June 1912 being a residence within said county of at least
 6 months next preceding the date of this petition. Petition filed under Act of June 29, 1906, as amended.

(10) I have NOT heretofore made petition for naturalization: No. , on ,
